Re: Important Notice: November Subsidy Payments

Dear Housing Providers,

We wanted to inform you that there may be delays or inaccuracies in payments scheduled to be issued in November.

Our team at the Executive Office of Housing and Livable Communities (EOHLC), together with our Regional Administering Agencies, is currently completing a software upgrade that may affect the processing of some payments in this upcoming check run. While most payments will not be impacted, we want to ensure that all housing providers are aware of the possibility in advance.

If your payment is affected, please know that we are working diligently to resolve the issue and will ensure that any missed or incorrect payments are corrected as quickly as possible. We expect to provide an update by the end of November.
